

RAGGING IS PROHIBITED

In view of the directions of the Hon'ble Supreme Court in SLP No. 24295 of 2006 dated 16-05-2007 and in Civil Appeal number 887 of 2009, dated 08-05-2009 to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, and thereby, to provide for the healthy development, physically and psychologically, of all students, ragging is prohibited strictly.

All the students are hereby warned/ advised not to indulge themselves in any kind of ragging in the college campus and hostels.

The incident of ragging, if any, can be reported on telephone nos. 01258-222439, 8607022439 and in case of any emergency/eventuality/incidence, Dr. Shalini Sharma (9466282040) and Dr. Gurvinder Singh (9416521541) may be contacted.

Fresher can also report the incident of ragging, if any, to the above mentioned officers.

The incident of ragging will attract a fine between Rs. 25000/- and Rs. 1 lac. When the persons committing or abetting the crime of ragging are not identified, the institute shall resort to collective punishment.

Ragging is no way to make friends with freshers. Seniors should set an example of decent behavior before newcomers.

Enquiry will be in a fair and transparent procedure keeping in view the principles of natural justice giving adequate opportunity to the student/s accused of ragging.
